Description	The Project involves the development of 200MW solar photovoltaic power projects by ACME Solar Energy Private Limited during 2014-2016. ACME Solar Energy Private Limited is owned by the ACME group, EDF Energies Nouvelles and EREN S.A.			
Objectives and Scope	The proposed transaction merits ADB's assistance for the following reasons: (i) ADB will provide support to the Indian solar power policy. (ii) ADB will finance multiple projects that likely would have been too small for separate financing by ADB. Further, by providing long-term project finance loans, ADB will enable ACME Solar Energy Private Limited to implement additional solar photovoltaic projects in a manner that delivers competitively priced solar tariffs to Indian distribution utilities. (iii) ADB's assistance will support the entrance of leading foreign renewable energy players (EDF Energies Nouvelles and EREN) into the Indian market.			

Linkage to Country/Regional Strategy	<p>The project is aligned with ADB's India country partnership strategy, 2013- 2017, which calls for investments in renewable energy development, particularly solar .</p> <p>The project is fully aligned with ADB's Energy Policy.Under ADB's Energy Policy, ADB's investments will focus on energy efficiency and renewable energy projects, as well as expansion of energy access. The policy states that support for renewable energy projects will be prioritized and broadened, with an objective to create a framework that makes investing in renewable energy commercially viable.</p> <p>The project is consistent with ADB's midterm review of Strategy 2020. The midterm review calls for investing \$2 billion annually in clean energy (including renewable energy). The midterm review highlights the key role of the private sector in climate change mitigation and confirms that ADB should continue to prioritize private sector operations in clean and renewable energy.</p>
